Malicious Assailant

Malicious Assailant covers incidents involving a lethal weapon (including vehicles) with the intent to cause harm to others. Our product provides affirmative cover, closing the gap left by conventional terrorism policies, as well as Casualty, workers compensation and other associated insurances – providing comprehensive coverage against the many ways in which losses can be incurred.



Strikes, Riots and Civil Commotion (SRCC)

SRCC cover protects organisations against property damage and business interruption losses caused by committed actions by a group of people to disturb the public peace for political purposes. Previous events triggering SRCC cover include: the Arab Spring protests across North Africa and the Middle East (2010), fuel price riots in Mexico (2017) and riots in Haiti (2018).



Political Violence

Political Violence insurance cover encapsulates war related perils including international and civil war, through to rebellion, coup d'état or revolution, as well as strikes, riots, civil commotion, malicious damage and terrorism and sabotage. Political Violence covers the spectrum of an organisation's war exposures to ensure there are no gaps in cover.

Our worldwide Sabotage and Terrorism product covers direct physical damage and business interruption from politically, religiously or ideologically motivated violent acts. The losses caused by these constant, unpredictable and hard to quantify threats can have significant impacts on a business' bottom line and are often excluded from standard commercial insurance policies.
